

## Reading guide to historic Triodos Bank Depository Receipt trading buffer overview

To facilitate the trade in its Depository Receipts of ordinary shares (DRs), Triodos Bank has historically been the counterpart in transactions where DR holders wanted to buy or sell DRs. To facilitate this temporary buy-in of its own CET1-capital instrument, Triodos Bank could make use of a dedicated so-called 'room to purchase DRs' (sometimes called 'the buffer').

The usage of the room to purchase is reported at year end in the Triodos Bank N.V. annual accounts.

In 2020, trading patterns in DRs were disrupted due to uncertainty in the economy resulting from the COVID-19 pandemic and trading DRs was [suspended](#) on 18 March 2020.

In October 2020 [trade was resumed](#) on the assumption that circumstances had improved sufficiently to re-establish a balanced trading pattern in the Triodos Bank DRs.

Upon reopening, it was decided to publish the usage of the room to purchase on a weekly basis, to allow investors to inform themselves about how trading patterns were developing, given that the events earlier in the year had caused an unprecedented shock to the trading system which had otherwise worked well for 40 years.

To enable the further understanding of stakeholders of the historic patterns of usage of the room to purchase, this document provides an overview of weekly patterns going back to 2007 (the year before the global financial crisis).

To report the use of the room to purchase, the actual transactions are used. In practice this means that the buffer is never zero. Depository Receipts may have been purchased at a different price than the price at which they were later sold due to timing differences. This means that there can be a negative or positive buffer amount in an overview even if there are no surplus DRs in the buffer. The amount shown in the overview represents a transaction profit or loss.

For the years 2007 – 2017 the maximum room to purchase DRs (buffer) was 2% of the outstanding capital. As the CET1 capital increased, the absolute amount of the room to purchase DRs also increased. For the years 2007 – 2009 the calculation of the maximum room to purchase DRs was done monthly.

From 2017 onwards the maximum room to purchase DRs was a fixed amount, due to a change in regulation. This amount was set with approval from DNB and the Triodos Bank General Meeting of shareholders.
